## Statistics on Commercial Sheep Slaughter State of Hawai'i, 2018–2024

Before the COVID-19 pandemic, Hawai'i's commercial slaughterhouses processed an average of 154,000 pounds of sheep annually. During the pandemic, the average total live weight increased by 5% to reach 161,000 pounds. The increase continued, reaching 176,000 pounds post-COVID, marking a 9% increase over the pandemic period, and a 14% increase compared to the pre-pandemic average.

However, year-on-year changes show high variability, ranging from -26% to +42%.

Chart 1: Total Live Weight of Commercial Sheep Slaughter and Year-on-Year Percentage Change, Hawai'i, 2018–2024



