- §4-27-1 Objective. The objective of this chapter is to control the use and registration of livestock brands.
- §4-27-2 <u>Definitions.</u> As used in this chapter, unless context otherwise requires:

"Brand" means a mark made by burning with a hot iron onto the surface of the livestock's hide to designate ownership;

"Department" means department of agriculture, State of Hawaii;

"Division" means division of animal industry, department of agriculture; and

"Livestock" means domestic animals used or raised on a farm, and does not include dogs and cats. [Eff. 12/15/83] (Auth: HRS §§142-2 and 142-41) (Imp: HRS §142-3)

- §4-27-3 <u>Division responsibility.</u> (a) The division shall maintain a list of all registered brands in a separate book known as the "Hawaii Brand Book."
- (b) All applications for brand registration shall be approved by the division to ensure that similar or duplicate brands are not being registered.
- (c) Each brand registered pursuant to section 142-41, Hawaii Revised Statutes, shall expire pursuant to the requirements of section 142-42, Hawaii Revised Statutes. The division shall notify all registered brand owners when the reregistration period opens and the media shall be advised by the department's public relations officer. - §4-27-4 Owner responsibility. (a) Owners shall register all livestock brands as required by statute. The owner shall submit a burnt cardboard imprint of the registered brand to the division for filing. [Eff. 12/15/83] (Auth: HRS §142-2) (Imp: HRS §§142-41 and 142-42)
- (b) Owners of brands who desire to transfer a brand registered with the department shall notify the division of the intent to transfer. The new owner shall register the brand with the department and shall pay the transfer fee. [Eff. 12/15/83] (Auth: HRS §142-2) (Imp: HRS §\$142-41 and 142-42)
- §4-27-5 <u>Fees.</u> The recording fee for each brand shall include a registration fee or a transfer fee. The following fees are established:
 - (1) Registration fee - - - - \$10; and
- (2) Transfer fee - - - - - - \$5

§4-27-6 Penalty. Penalties for:

- (1) Using the registered brand of another person;
- (2) Using an unregistered brand;
- (3) Obliterating a brand; or
- (4) Branding a person's livestock with the brand of another shall be as provided in sections 142-45 to 142-48, Hawaii Revised Statutes. [Eff. 12/15/83] (Auth: HRS §142-12) (Imp: HRS §\$142-45, 142-46, 142-47, and 142-48)
