He asked if she is purchasing 33 this property from Kamehameha Schools. 34 35 Ms. Scheibe said it is RDP Simple and it is under a private owner. 36 37 Bianca Sophia Antonio was called forward online to speak. She said this is a separate well that was created in this private subdivision and is not related to Kaupo Ranch well 38 39 that is on Kaupo Gap Road. She added that there is a contract through Kamehameha

Schools that if their well breaks down, they would utilize her well to help cover water

needs. This property is below ranch headquarters, and the well is not under the County

Sin 16 17 expressed gratitude for the traditions and education he received from the Japanese farming community and the Aloha spirit in Hawaii. Mr. Kau notified the Board that on the back page of the submittal, Attachment A does not exist, and it was an erroneous inclusion.

1 Motion to Approve: Ley/Gomes 2 3 Public Testimony: 4 Raymond Sin spoke on the philosophy of Ho'oponopono (balance and harmony with 5 nature). 6 7 Tara Rojas spoke about the broader water crisis, the drought's impact, and urged the 8 Board to 'decolonize their mindsets' and amend the bylaws as needed. 9 10 **Board Discussion:** 11 Member Gomes asked if the county would be able to use the reservoir water in case of 12 a brush fire. 13 14 Mr. Kau said they are on Board with that. 15 16 Member Gomes added that during a drought, they plan for rain and when there is rain, 17 they plan for drought. The droughts are getting worse every year. 18 19 Member Oswald questioned the four-month duration of the water provision for ranchers, 20 asking how difficult it would be to extend it if the drought continues. Mr. Kau replied that 21 it wouldn't be difficult but would require an amendment, and any extension also depends 22 on reservoir levels. Member Oswald also asked if there were set reservoir height 23 thresholds for conservation measures, to which Mr. Kau explained that it's a floating 24 target dependent on the time of year and weather dynamics. He also inquired about 25 protections for existing priority users. Mr. Kau confirmed that Section 4-157-4H 26 prioritizes preserving crops and animal life, and the local farmers support diverting some 27 water for ranchers. 28 29 Member Ley asked if outreach had been done to all cattle producers. Mr. Kau 30 responded that the cattlemen have been communicating well with each other, and the program primarily helps high-level ranchers who need to haul water. 31 32 Chairperson Hurd gave kudos to the Agricultural Resource Management Division for 33 their quick action upon realizing from the public that there was a dire need. 34 35 Vote: Approved: Unanimously 36 37 C. Member Ley sought clarification on the motion, which was confirmed to be an approval of the staff's recommendation and not the petition itself. Member Gomes expressed concern about the timeline and the need for interim protection for Molokai while new rules are being formulated.

## Public Testimony:

Public testimony was given by a representative for the petitioners, who spoke on the cultural and subsistence significance of coconut trees (Niu) on Molokai, the devastation caused by Coconut Rhinoceros Beetle (CRB) elsewhere, and urged the Board to act immediately to protect their island and cultural heritage.

23 Multiple testifiers from Molokai and other islands spoke in strong support of the petition.

They emphasized the cultural and economic importance of coconut trees and other

plants threatened by the CRB. Speakers highlighted that Molokai is the last island free

from CRB and that prevention is crucial. Testimonies pointed out the failure of current

27 inspection systems, citing the spread of CRB to other islands despite them.

Concerns were raised about the devastating impact of CRB on Oahu and other islands, 28 serving as a warning for Molokai. The high cost and difficulty of eradication compared to

prevention were repeatedly mentioned. Speakers urged the Board to act proactively to

protect Molokai's food security, cultural heritage, and self-sufficiency. It was also

mentioned that there is a lack of enforcement, inspection, and treatment capacity on Molokai's ports.

### **Board Discussion:**

The Board discussed that the motion was too general and did not reflect the urgency and specific direction the Board wished to convey. There was a consensus that a more specific motion was needed to direct the division to expedite the rulemaking process, including taking the petition language to the advisory committee and ensuring it returns to the Board by the next meeting. Member Ley supported prioritizing action on the petition with guidance from the Plant Quarantine branch, ensuring broad transparency, and increasing inspections for shipments to Molokai.

VI. NEW BUSINESS

1. NON-ACTION ITEM: Invasive Species Action Plan Updates

Jonathan Ho, Plant Quarantine Branch, presented new business item.

Presentation:

Update on federal funding for biosecurity, specifically for brown tree snake interdiction and the Hawaii detector dog program. Approximately \$400,000 is received annually, with the grant cycle typically between April and June. This year, the grant was initially announced in December 2024 with an April 2025 submission date, then re-released in July of this year with an August 2025 submission date.

A large-scale hiring event was held at the Plant Quarantine branch, with interviews on August 20 and 21, and a job fair on August 20, from 9:00 am to 2:00 pm. This event was the first of its kind and proved to be very successful.

For CRB response on Kona, two large piles of green waste (approx. 1,500 cubic yards) in the Agricultural Park (Ag Park) were found infested with CRB. Department staff, the Hawaii Invasive Species Council, and Department of Transportation were involved in the initial thorough survey and treatment. On August 13, all piles were tarped and fumigated. An additional pile (~2,300 cubic yards) was found and treated last week. Treated green waste was taken to a processing facility, ground, and immediately composted to raise its temperature, preventing re-infestation. Widespread surveys and tree treatments (injectable or crown sprays) are ongoing throughout the Ag Park and Kona area.

1 Plant Quarantine is working on getting sustained funding to expedite vendor selection 2 and treatment/removal of infested piles, aiming for rapid response capabilities in each 3 county across the state to avoid procurement delays. 4 5 Public Testimony: 6 Nākai'elua Villatora testified that there was an ongoing lack of county and state support 7 despite communicating with the Department of Agriculture and the pesticide branch.
